

Question of the Month

**Question:** Are the SCAN-3 tests (both Children and Adolescents/Adults) screening or diagnostic tests?

Answer: They are both. SCAN-3 contains three screening measures that can be used to determine if the entire battery should be administered. If an examinee fails

the screening tests, or if there is a referral for diagnostic testing, then the audiologist can proceed with the diagnostic portion of the test. The criterion-referenced norms provide cut scores for determining pass/fail of the screening measures. The SCAN-3 diagnostic tests include standard scores with percentile ranks and confidence intervals that are important in the interpretation of test results.
